#### AREA PERMIT AGREEMENT 2018 BETWEEN MININERA & DISTRICT FL & STAWELL 13 & UNDER FOOTBALL ASSOCIATION

This Agreement is signed pursuant to the AFL Vic Country rules and regulations pertaining to clearances and permits and in particular rule 2.10 Area Permits, whereby an interchange of players between two leagues may take place without clearance or permits and is subject to any provisions contained within this agreement.

### **PROVIDED HOWEVER**

- 1. That this agreement is in place commencing from the 2021 season.
- 2. Future amendments can be requested by any party as long as amendments are requested once in any 12-month period and are made prior to 28 February in the year prior to the season commencement.
- 3. The area agreement can be unilaterally terminated by any party as long as notice is given to all other parties prior to 28 February in any given season. Unilateral notice of termination given after 28 February will only apply to the season in the next calendar year.
- 4. By mutual agreement, the timelines as provide for in section 2 and 3 above may be waived or amended
- 5. That the player(s) involved desire to play with the club in the other League/Association on the day in question.
- 6. That the clubs involved are agreeable to the players playing on the day in question.
- 7. That the players are registered players within AFL Vic Country.
- 8. That the players concerned are aware of the AFL Vic Country regulations 2.1, 2.2 and 2.5 regarding permits. The conditions referred to in Rule 2.2 do not apply under this agreement. There is no 8 game restriction under this agreement.
- 9. That prior to player(s) first match with the chosen club the player(s) must obtain written permission from the club where he/she is registered.
- 10. The Permit Form signed by the player is valid for the season. The player need only sign one Permit Form, this form to be valid for the season.
- 11. The Permit Form must be signed in triplicate, one copy sent to the Stawell 13 & Under Football Association Secretary, one copy to be sent to the Mininera and District FL and one copy held by the player(s) registered club.
- 12. The player(s) at any time during the season may interchange between the Stawell 13 & Under Football Association and the Mininera & District Football League back to their registered club.
- 13. Players can only apply for a Permit to play with one club in the season.
- 14. At all times the player(s) will remain registered with their club of origin for the season.
- 15. Permit players must be listed on the team sheet as area permit players. Failure to do so could see the club penalised under AFL Vic Country Rule 1.3 (ineligible players).
- 16. Finals qualification will be based on the local finals qualification by-laws for each League/Association.
- 17. All permits shall be transacted via the AFL Game Day permit system using the match day permit option with the requested date only specified.

### **Reported Players**

A player that is reported shall face the independent Tribunal for the league of which the offence was committed. Any penalty that is imposed shall apply for all competitions.
