AREA AGREEMENT

Between

Western Victoria Female Football League and Mininera & District Football League

This agreement is signed pursuant to the AFL Vic Rules and Regulations pertaining to clearances and permits and in particular Rule 2.10 and – Area Permits whereby an interchange of players between clubs of the above mentioned Leagues may take place without clearance or permits and is subject to any provisions contained within this agreement

- 1. That this agreement is in place commencing from the 2021 season.
- 2. Future amendments can be requested by any party as long as amendments are requested once in any 12month period and are made prior to 28 February in the year prior to the season commencement.
- 3. The area agreement can be unilaterally terminated by any party as long as notice is given to all other parties prior to 28 February in any given season. Unilateral notice of termination given after 28 February will only apply to the season in the next calendar year.
- 4. By mutual agreement, the timelines as provide for in section 2 and 3 above may be waived or amended.
- 5. That the player(s) involved desire to play with the club in the other League on the day in question.
- 6. That the player(s) involved desire to play with the WVFFL or Mininera & District FL
- 7. That the player(s) concerned are aware of the AFL Vic Rules 2.1 and 2.5 regarding permits. The conditions referred to in Rule 2.2 do not apply under this agreement. There is no eight-game restriction under this rule.
- 8. That prior to the player(s) first match with the chosen club the player(s) must obtain written permission from the club where she is registered.
- 9. The Permit Form signed by the player is valid for that Season only. The player need only sign one Permit Form, this form to be valid for the season.
- 10. The Permit Form must be signed in triplicate, one copy sent to the MDFL and one copy sent to the WVFFL and one copy held by the player(s) registered club.
- 11. The player(s) at any time during the season may interchange between the MDFL and the WVFFL back to their registered club.
- 12. Players can only apply for a Permit to play with one club per season.
- 13. At all times the player(s) are registered with their club of origin for the relevant season.
- 14. For Permit players to be eligible to play in either League's finals the player must be qualified under the local qualification rules.
